



A Focus on the Future

FROM MATT CARSTENS

Our success at Landus is owed to the commitment of our employees, and the continued engagement of you, our farmer-owner. Thanks to your support, I am proud to share that the financial health of your cooperative is at an all-time high.

Our team delivered record profitability

for the fourth consecutive year, growing topline sales to nearly \$2.4 billion and net income before tax to \$37 million despite a challenging operating environment in FY 2023. lust as you experienced the pain of spiking interest rates on your farm, Landus absorbed a record \$3 million in additional cost from increased interest rates alone. At the same time, our industry experienced extreme volatility in agronomy markets and navigated the waves of input price swings. But the team remained focused on removing unnecessary links from the agronomy supply chain, locking in the best possible pricing on your behalf, and mitigating risk to your cooperative. Our grain team continued to leverage rail advantages and enduser relationships to connect your grain to the right markets, and our animal nutrition team optimized efficiencies and found new destinations for our value-added soybean meal, SoyPlus®, and soy oil. This is a team committed to finding solutions, not making excuses,

and their hard work and focus on your needs led to the results you will see in this annual report.

Strong financial performance alone is not what should matter most to you though. Where, and how, your cooperative invests those funds is key. In addition to paying two cents per bushel in 100 percent cash patronage on FY 2023 grain business, Landus reinvested record amounts back into the insights and infrastructure necessary to serve the farmer of tomorrow

We invested more than \$120 million into facilities of the future through both enhancements to existing core hubs and additions of new greenfield locations. When you asked for more, we listened, and we announced plans for a future grain and agronomy facility north of Fort Dodge, Iowa, as a direct response to local farmer feedback. In Boone, we're underway building a \$16 million fertilizer manufacturing and repack facility backed by a \$5 million **USDA** Fertilizer Production Expansion Program Grant. The Boone site will also showcase our recently announced partnership with Talus Aq with a pilot green ammonia production system and the potential to decrease the carbon intensity score of crop production.

Beyond just physical assets, we're also investing in the innovative solutions that will support you and your family's operations well into the future. In collaboration with DEFENSEWERX, the world's largest innovation ecosystem serving top military, defense, and intelligence agencies in the U.S., we launched LANDWERX, the first DEFENSEWERX hub focused on solving the most pressing onfarm challenges. Through LANDWERX, we now have unprecedented access to the inventors, thought leaders, and difference makers from industries beyond just agriculture who can help us deploy solutions to challenges. Landus will continue to lean into the future and work to solve the most pressing challenges facing the future of agriculture and our rural communities. While it will always be our first responsibility to get our core business right, we will never settle for table stakes solutions, because rural America needs more.

I hope you take the time to read through the pages of this annual report to get a deeper look at the team's achievements from FY 2023 and better understand the work driving our financial performance. And, as you review our summarized financial statements and commentary, please remember one thing: the growth achieved this year was done organically and without any mergers involved. Going forward, Landus will remain focused on sustainable growth and will not allow our business to be weighed down by the complexity and distractions of cooperative mergers. That strategy is no longer serving farmer-owners' interest, and we remain committed to a better path forward.

Thank you for your continued engagement and support of your cooperative. Landus will continue to put your needs at the center of everything we do, and we will never shy away from trying to solve the most pressing problems facing you and your operation, because that's precisely what the cooperative was designed to do.



LANDWERX

The launch of LANDWERX this year put farmers back in the driver's seat of ag innovation and provides Landus farmerowners unprecedented access to the world's largest innovation ecosystem that has proven invaluable to leading military, defense, and intelligence agencies. Food security is national security, and LANDWERX activates world-class change makers to create meaningful advancements in the agriculture space on behalf of farm operators.

This joint venture between the leading innovation ecosystem, DEFENSEWERX, and Landus grants farmers previously unattainable access to problem solvers and solutions and brings together nontraditional collaborators to address the biggest on-farm challenges. To truly uplift and empower our country's

leading on-farm operators, LANDWERX is reversing the script on ag innovation and placing the focus squarely on farmers. Through this newly launched innovation platform, we're leveraging the national security, intelligence, and defense communities' leading innovation networks and processes to start solving the farming problems that can make the greatest impact to operators.

As a direct result of LANDWERX innovation and collaboration, Landus has partnered with Talus Ag, a renewable energy equipment manufacturer, to create a production facility for green ammonia in Boone, lowa. This will be the first green ammonia production facility in the United States. This facility, and others to follow, will help farmers reduce their carbon footprint, and lower their costs by taking links out of the supply chain.

Landus Conduit is the wholly owned subsidiary of Landus that provides solutions to ag retailers and farmers, linking them with the downstream consumers of sustainably raised food and fuel. By providing Landus expertise, partnering ag retailers can build their business with the assistance of Landus Conduit.

Since its launch, Bruce Vernon and his team have grown Landus' presence, not only across state boundaries, but across international borders to bring Landus grain merchandising services to farmers across North America. The keystone that bridges farming today to the future of farming is the development of the asset-light model.

Conduit offers a unique service to noncompetitive ag companies that don't need a physical location to benefit a company.

Conduit is able to offer grain, agronomy, and processing services to these ag companies, as well as the services of the GROW Solutions Center.

Boone Chemical Facility

By fall 2024, our Boone location will become the epicenter of our agronomy services. The \$16 million state-of-the-art facility being built in Boone received \$5 million in funding from a USDA grant presented by U.S. Secretary of Agriculture, Tom Vilsack, in June. The renovations of the facility will add a new freestanding chemical and seed storage building and a manufacturing facility that will produce a full lineup of Landus agronomy products, with the ability to ship across the Midwest. Complete with the capability to manufacture foliar, slow-release nitrogen (SRN), the USDA grant allows the Boone facility to enhance the precision of SRN by reducing the overall amount of nitrogen applied while also lowering the carbon footprint required to produce, store, and ship. With direct ship options receiving more emphasis for 2024, agronomy products of all varieties coming out of Boone will be available to virtually every farmer across the Midwest.

Boone's recent improvements allow Landus to take advantage of off-season chemical purchases by having heated bulk storage available. With this update, Landus will repack bulk chemicals into totes at one facility rather than multiple as we were cornered into doing with our previous technology.

Landus Innovation Connector

More than 1,000 farmer-owners connected with Landus leaders and emerging ag innovations throughout the 2023 series of Innovation Connector events. This year, the Innovation Connector featured a variety of farming solutions, ranging from drone technology, to pollen preservation, to sustainable agronomy products.

In addition to offering farmer-owners the opportunity to connect directly with President & CEO, Matt Carstens, and leaders from Landus, the Innovation Connector attracted speakers like U.S. Secretary of Agriculture, Tom Vilsack; Iowa Secretary of Agriculture, Mike Naig; and USDA State of Iowa Director, Theresa Greenfield.

Shuttle Train Growth

Landus has been an active shuttle owner and freight market participant on both the UP and BNSF rail lines since January 2022. Owning a shuttle (110 railcars) is a one-year contractual agreement between a railroad and a customer like Landus. Through this agreement, Landus is responsible for keeping the shuttle moving. Landus continues to leverage

freight ownership and end-user relationships to grow demand for Landus corn and soybeans. This has been a competitive advantage in certain areas and helped us grow market share in strategic destination markets. Landusowned shuttles have loaded at Landus locations 90 times since early 2022.



Dairy Production Insights

Landus continues to be a leader in the dairy nutrition industry with our flagship product, SoyPlus. As the dairy industry consolidates into larger farms, SoyPlus production demand will continue to increase. Despite the rail service challenges available for these farms, the SoyPlus production team crushed 25.4 million soybean bushels — a new annual year record. Landus has captured higher margins on soybean oil by improving oil refining and diversifying sales into the renewable diesel market. In addition, SoyChlor® continues to see strong growth both domestically and internationally, with sales in over 15 countries.

Green Ammonia

Landus has entered an exclusive Iowa partnership with Talus Ag, the world's first modular green ammonia system, which enables local production of low-cost, carbon-free fertilizers and renewable fuels. This production facility will be a part of the new fertilizer manufacturing and repackaging facility expansion in Boone, Iowa. The green ammonia plant will be powered by a six-acre solar bank, creating a 100% renewable energy source for the entire 70-acre Landus Boone site. By producing green ammonia on-site, Landus will eliminate a projected 50% cost of freight and uncertainties from the supply chain, support sustainable farming, and lower the overall cost of nitrogen fertilizers by up to 50 percent.

The expansion of the Boone facility will allow Landus to provide direct ship distribution options for farmers and suppliers across the Midwest, while taking advantage of Landus' unique position as the only lowa agribusiness with access to all seven railroads.

Talus Ag has recently opened their first green ammonia production facility in Africa in partnership with the Kenya Nut Company. The Boone facility will be the first green ammonia plant in the United States.



Community Investments

Rural vitality is one of the key focuses of Landus. To ensure rural continues to grow, Landus has poured even more efforts into rural community development. New scholarships and land donations are just a few ways Landus shows gratitude to the communities we're a part of.



Strategic **Investing in Our Core Business**

With today's large farm equipment and more farmers demanding direct ship options for both grain and agronomy, Landus is quickly adapting our assets and go-to-market strategies to meet the demands of the farmer of tomorrow. Mergers are an action of the past. Landus' asset-light model focuses on investing into facilities of the future at strategic hubs, and helping farmers invest in on-farm grain storage and agronomy assets. Between 2022-2024, we'll invest an additional \$158 million total in capital expenditures across our network into strategic assets that drive profitability for our core business.




